Update

Pat Hall, Alison Oldham, Steph Hughes, and Ros Slowley have stood down over the last 12 months, after many years of faithful service. We also lost Mick Berry in very sad circumstances.

We have welcomed Rachel Hudson and Jenn Varney, Michelle Kynaston, and Mike Skinner over the year, and have also just appointed Carl Stacey and Simon Gittins to fill two long-standing vacancies. They bring further HR, financial and business skills and interests to our board.

What do Governors do?

Governors provide strategic leadership and accountability in our school. They hold the main responsibility for finance in school and work alongside the Executive Headteacher to make decisions about budgeting. Governors work with the schools to set the strategic direction, aims and objectives, and to monitor and evaluate the progress the school is making towards achieving them. They appoint, support and challenge the senior leaders.

Class Structure

We are delighted that Ruyton will be remaining at 4 classes this year, and that Bomere Heath will be going back up to 5.

Academisation

Governors have worked hard this year in discussions regarding the possibility of forming a MAT, (Multi Academy Trust) ensuring that we are in the best position to shape our own destiny and safeguard the ethos and values of both our individual schools. Due to recent changes in the government's message regarding MATs, we have decided to put these discussions on hold.

GDPR

The governing body has overall responsibility for ensuring that our school complies with all relevant data protection obligations. On 25 May 2018, new General Data Protection Regulations (GDPR) came into effect changing the way that personal data is processed. This underpins the way that we look after the personal information that we hold about you, your children, and our staff.

Over the last few months, the link governor for GDPR, on behalf of the governing body, has worked closely with the Executive Headteacher to prepare the federation and ensure compliance with these new regulations. This has included undertaking an audit of what information we hold and why, introducing a new data protection policy, and making changes to the way that some information is held and used to make sure it is as secure as possible. We have also appointed a Data Protection Officer, who will undertake an annual review of the federation's data protection practices, and is the first point of contact in the event of any concerns about how personal information is handled within the federation.

Governor Training

As governors we undertake a range of training over the year to support us in our work.
